First Meeting of the Bureau of COP11 of the Nairobi Convention

30-31 January 2025 Dar es Salaam, United Republic of Tanzania

1. Background

The Nairobi Convention serves as a critical framework for the protection, management, and development of the marine and coastal environment in the Western Indian Ocean (WIO) region. The Nairobi Convention's work is supported by a Bureau composed of representatives from member states, the terms of Reference of the Bureau of the Nairobi Convention were developed at the <u>first COP of the Convention</u>. The Bureau assists in the general conduct of the business of the Conference of Parties and serves in that capacity at any intervening extraordinary meeting or Conference of Parties. The Bureau reviews and evaluates the progress of implementation of the Nairobi Convention between ordinary meetings of the Contracting Parties to the Nairobi Convention. As the Convention's scope and complexity expand, there is a need to equip bureau members with an understanding of the mandates, roles, protocols, and ongoing and emerging issues related to sustainable ocean governance.

In accordance with the rules of procedure for meetings of the Contracting Parties to the Convention and their customary practice, the Contracting Parties elected the following members to serve as the Bureau of the Nairobi Convention during the intersessional period between the eleventh and twelve meetings of the Contracting Parties to the Convention:

President: United Republic of Tanzania

Vice President (Programme of Work): Mauritius

Vice President (Resource Mobilisation): Republic of South Africa

Vice President (Coordination): Somalia

Rapporteur: Madagascar

The first meeting of COP11 Bureau will also be attended by National Focal Points to the Nairobi Convention to familiarize them with the Convention's operational processes, governance structures, and strategic priorities. This initiative aligns with recent decisions adopted during COP11 in Antananarivo in August 2024, particularly in addressing the strengthening of governance frameworks and capacity building.

2. Objectives of the meeting

The meeting of COP11 Bureau is designed to:

- Equip Bureau members with tools for effective decision-making and engagement processes.
- Familiarise the Bureau members to their mandates under the Convention.
- Provide an overview of recent trends of COP decisions.
- Foster a shared understanding of the strategic priorities of the Convention.





• Strengthen the Bureau members ability to engage in and foster communicate between their national governments, regional partners, and other stakeholders.

3. Expected Outcomes

- a comprehensive understanding of the Nairobi Convention's structure, operational framework, and the integrated regional strategy 2025-2035 and the 2025-2028.
- roles and responsibilities as Bureau members well understood.
- the Conventions work and implement of decisions of COP11 and other previous decisions effectively guided.
- networking opportunities amongst the bureau members and key stakeholders within the WIO region enhanced.

5. Next Steps

Following the induction, bureau members will be encouraged to participate in follow-up workshops, regional dialogues, and sessions to reinforce knowledge and address any further questions related to their roles.
