Why WIOSAP

Goal: improve and maintain the environmental health of the region's coastal and marine ecosystems through improved management of land-based stresses.

Specific Objective: To reduce impacts from land-based sources and activities:

- *By Sustainably managing critical coastal and marine ecosystems*
- *Through the implementation of the agreed WIO SAP priorities*
- *With the support of partnerships at national and regional levels*



Programme Components

Component A: *Sustainable management of critical habitats*

- Management planning and implementation
- Marine spatial planning
- Ecosystem restoration
- Economic valuation
- Pilot ICZM planning and implementation
- Alternative livelihood interventions



Component B: *Improved water quality*

- Cost-effective technologies for municipal wastewater treatment demonstrated
- Effluents are collected, treated, recycled and/or disposed of in accordance with international best practices
- Marine litter interventions



Component C: *Sustainable management of river flows*

- Environmental flow assessments conducted in pilot river basins
- Implementation of flow assessment recommendations and participatory river basin management approaches



Component D: *Governance and Regional Collaboration*

- **ICZM protocol developed** and adopted at the regional level and national level
- **LBSA protocol ratified** in at least four (4) countries and supported in all countries through the development of policy briefs, model legislation and capacity building to practitioners
- **Establishment of a funding pipeline** to support long-term implementation of the SAP
- **Learning and exchange** in support of WIOSAP project implementation
- **Established science-policy exchange platform** under the Nairobi Convention
- **Enhanced cooperation** between the Nairobi Convention and regional economic/trade organizations (e.g., SADC, IOC, EAC, etc.)



Structures for WIOSAP Implementation

- **PMU:** Project Manager, Technical Officer, Admin Assistant, *Policy and Comms Officers*
- **National Implementation Committees (NICs)**
- **Regional Task Forces** – Component level: Discussing on possible shared roles with SAPPHIRE Project
- **Science to Policy Platform:** Science – Policy interface
- **Project Steering Committee (PSC)**
- **Implementing Agency (IA)/UNEP:** Oversight



TORs of Regional Task Forces

- Support the review of concepts and proposals for demo projects including giving technical support for the improvement of proposals considered viable for funding
- To provide a mechanism for exchange of information and experience
- Identify, review and propose ways of strengthening technical collaboration across the region...
- Give suggestions in fundraising for the development of a pipeline for WIOSAP sustainability
- Monitor and document lessons in the implementation of selected in-country interventions



TORs of Regional Task Forces

- Identify and review capacity building needs
- Provide support in the development of relevant environmental education programmes
- Compilation of regional syntheses regarding policy, management needs and priorities;
- Evaluate progress in implementation of Component A of the Programme, and provide guidance for improvement when necessary
- Provide periodic progress reports to the WIOSAP PMU and when required the Project Steering Committee
- Lead in the development and production of case studies capturing best practice and also periodic peer reviewed publications based on works from the Project



Appointment of Regional Experts

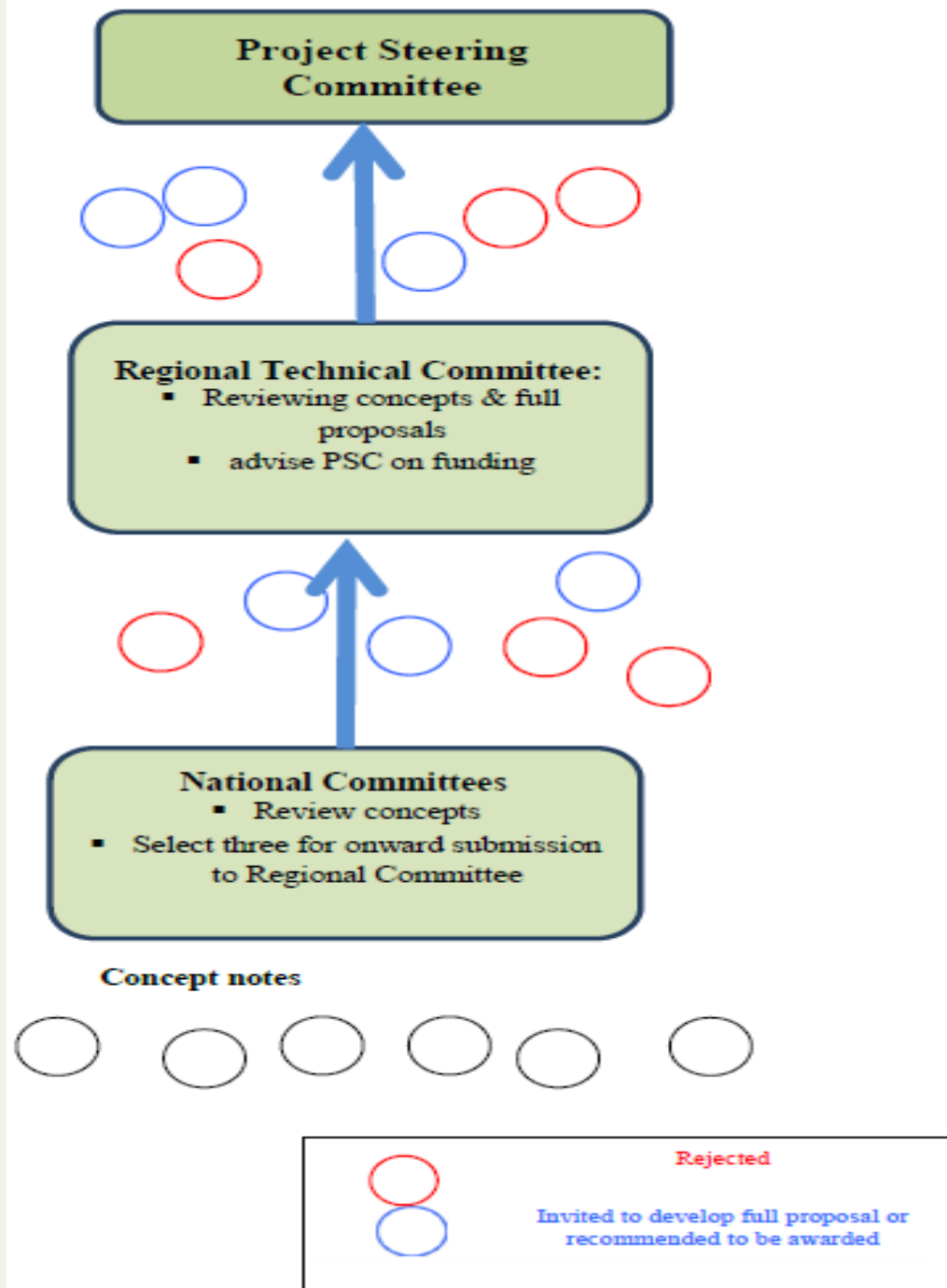
- Approval of TORs by Focal Points in April
- Formal request by PMU to countries
- Nomination by Focal Points.....
- Official invitation by the PMU
- Complimentary expertise
- Shared roles between SAPPHIRE and WIOSAP



National level review

- Background documents
- Call with a dateline of 28th July 2018
- Extended dateline to 15th August 2018
- Approval of review process and criteria by the Project Steering Committee (PSC) in August 2018
- PSC approved TORs for National Implementation Committees (NICs)
- Approved criteria and process shared with Focal Points early September 2018 to kick off National review
- Role of NIC very critical....

NIC Submissions

- Review period: September to December 2018
- Countries submitted:
 - *Kenya*
 - *Mauritius*
 - *Madagascar*
 - *Republic of South Africa*
 - *Seychelles*
- Other countries in 2nd round
- Need for urgency: Legacy of the Project, time required
- Technical support where required



Criteria for Experts evaluation

Major focus is on technical and regional relevance

- Adequacy of background and justification of the proposed intervention
- Clarity of objectives, aligned to the problem statement/justification and achievable within the project timeframe of 2.5 years
- Alignment of expected results to the proposed objectives?
- Regional relevance and potential for replication/up-scaling beyond the proposed site/country
- Need for major/further technical input
- Recommendation/not for full proposal development



Process for next 2 days

- Respective Task Forces appoint their Chairs
- Chair coordinates collation of comments for each concept at Component level
- Chair facilitates final recommendation for each concept with solid supporting comments
- Chair reports back to plenary on each concept focusing on major comments and final recommendation
- PMU will seek approval to proceed with call for full proposals for recommended concepts
- *Role of Focal Points – neutral role.....*
