Small-Scale Funding Agreement

THIS SMALL SCALE FUNDING AGREEMENT (SSFA) and its annexes (this "Agreement") is made Upon signature.

BETWEEN:

United Nations Environment Programme (hereinafter referred to as "UNEP") having its office at P.O. Box 30552-00100, Nairobi, Kenya and represented by its Ecosystems Division, an international inter-governmental organisation established by the General Assembly of the United Nations.

AND:

The Vice President's Office of the United Republic of Tanzania (hereinafter referred to as "VPO"), a government represented by its permanent secretary and having its office at 40406 Government City, Mtumba area P.O. Box 2502 Dodoma.

Based on the Nairobi Convention Contracting Parties Decision CP.10/12 on developing projects and strengthening partnerships, UNEP agrees to co-operate with the VPO with respect to the project titled Enhancing Ecosystem-Based Management approach for improved livelihood to fisheries communities in Mkinga District, Tanzania. between UNEP and The Vice President's Office, United Republic of Tanzania, UNEP agrees to co-operate with VPO with respect to the project/programme entitled "Enhancing Ecosystem-Based Management approach for improved livelihood to fisherles communities in Mkinga District, Tanzania" in Mkinga District, Tanzania. Annexes to this Agreement, including the attached Project Document/Implementation Plan (Annex-A) and Budget (Annex-B) are part of this agreement.

- 1. Project/Programme objectives to which the small-scale funding contributes:
 - The partnership project between the Nairobi Convention (NC) and the South West Indian Ocean Fisheries Commission (SWIOFC) (NC-SWIOFC partnership project) addresses marine and coastal governance and fisheries management for sustainable blue growth. The partnership project is funded by the Swedish International Development Cooperation Agency (SIDA) through the UN Food and Agriculture Organization(FAO). The project seeks to enhance the resilience of livelihoods based on WIO marine and coastal ecosystems and habitats, to promote sustainable management of coastal fisheries using the ecosystem approach to fisheries, and to enhance coordination between fisheries and environmental management institutions at national and regional levels. In particular, the project will support the development of management plans/strategies for adoption at the national level for the conservation of selected critical coastal habitats with a shared concern for fisheries and environmental management.
- The SSFA will contribute to achieving Component 1 of the NC-SWIOFC project, centred on the protection and management of the coastal and marine ecosystems. It focuses on addressing the link between the health of marine and coastal ecosystems in the Western Indian Ocean (WIO) region and fisheries productivity; and also, the impacts of fisheries on the capacity of these ecosystems to provide inherent goods and services. The objectives of the project will be achieved through the implementation of a national demonstration project entitled "Enhancing Ecosystem-Based Management approach for improved livelihood to fisheries communities in Mkinga District, Tanzania". The demonstration project will be implemented in three sites namely Jasini, Mayomboni/Mayumboni, and Doda. The sites are located between Mkinga and Tanga municipality. The demonstration project seeks to address the need for an enhanced ecosystem-based approach to protecting key critical habits in order to increase the resilience of livelihoods and reduce the vulnerability of dependent coastal fisheries communities of Mkinga District.

The projects contribute to UNEP's Regional Seas Strategic Direction (RSSD) 2022-2025 and contribute to the delivery of UNEP's Medium-Term Strategy (MTS) 2022-2025 and Programme of Work (PoW) 2022-2023 on activities that address ocean-related priority areas such as nature action and environmental governance. It also responds to the new UNEP Marine and Coastal Strategy (2020–2030) Objective 1 to "establish a knowledge-base on marine and coastal ecosystems to inform policies on human activities affecting their functions", Objective 2 to "build circularity in economies and promote sustainable consumption and production approaches to address marine pollution and resource use" and Objective 3 to "support policies and strategies that enable the integrated management and sustainable use of marineand coastal ecosystem services".

- 8.a. VPO shall submit financial statements on the use of funds provided, as per UNEP's required format and within the agreed timeframe.
- 8.b. VPO shall keep accurate and up-to-date records and documents in respect of all expenditures incurred with the funds made available by UNEP under this Agreement, to ensure that all expenditures are in conformity with the provisions of this Agreements and its annexes thereto.
- 8.c. Upon completion of the Project/or Termination of this Agreement, VPO shall maintain the records for a period of at least 3 years unless otherwise agreed upon between the Parties.
- 8.d. UNEP has the right, at its own expense, to have the records of VPO related to this cooperation reviewed and audited.
- 9.a. VPO shall consult with UNEP regarding the Intellectual Property Rights as appropriate.
- 9.b. VPO shall only use the UNEP name, logo, and emblem in connection with the Project/Programme with the prior written consent of UNEP.
- 9.c. In no event will authorization of the UNEP name or emblem, or any abbreviation thereof, be granted for commercial purposes.
- 10. This agreement can only be changed through an agreed modification in writing.
- 11. Either party may terminate this Agreement upon serving a written notice to the other party at least 3 month(s) prior to such termination.
- 12. VPO shall comply with all the above-mentioned provisions and agrees that UNEP reserves the right to withhold any payment due to VPO's non-compliance with any of the provisions mentioned hereinabove.
- 13. Any dispute arising out of or in connection with this Agreement shall be settled amicably between UNEP and VPO. Should attempts at amicable negotiation fail, any such dispute shall, upon request by either party, be referred to arbitration in accordance with the UNCITRAL arbitration rules. The parties shall be bound by any arbitration award rendered as a result of such arbitration as the final adjudication of any such controversy, claim or dispute.
- 14. This Agreement shall enter into force upon signature by the Parties being effective from the date of the latest signature, and shall remain valid for a period of *12 months*, after the end date specified in clause 4 unless terminated earlier pursuant to clause 11 above.
- 15. The Parties shall carry out their respective responsibilities in accordance with the provisions of the Agreement. The Parties shall determine and communicate to each other their respective focal points, having the responsibility for the Project implementation on its behalf.
- 16.a. VPO shall be solely and completely responsible and accountable for all services performed by its personnel, agents, employees, or contractors (hereinafter referred to as "Personnel").
- 16.b. VPO shall be considered as having the legal status of an independent contractor. Personnel of VPO, its contractors or anyone else working for VPO in the execution of the Project or otherwise, are not employees of UNEP and are not covered by the privileges and immunities applying to UNEP and its staff pursuant to the Convention on the Privileges and Immunities of the United Nations. UNEP shall not accept any liability for claims arising out of the activities performed under the Agreement, or any claims for death, bodily injury, disability, damage to property or other hazards that may be suffered by VPO's Personnel as a result of their work pertaining to the activities under this Agreement.

- 16.c. VPO shall ensure that its personnel meet the highest standards of qualification and technical and professional competence necessary for the achievement of the objectives and results of the Project, and that decisions on employment related to the Project shall be free of discrimination of any nature. VPO shall ensure that all personnel are free from any conflicts of interest relating to the Project activities.
- 17.a. VPO shall not seek nor accept instructions regarding the activities under the present Agreement from any Government or other authority external to UNEP.
- 17.b. VPO shall refrain from any conduct that would adversely reflect on the United Nations and shall not engage in any activity which is incompatible with the aims and objectives of the United Nations or the mandate of UNEP.
- 18. Nothing in or relating to this Agreement shall be deemed a waiver, express or implied, of any of the privileges and immunities of the United Nations and UNEP.
- 19. This Agreement or its Annexes may be modified or amended only by written agreement between the Parties.
