





Mission to Mozambique WIOSAP Demo Projects Implementing Partners 6th to 14th Feb 2023 Concept Note

1.0 Introduction

The Contracting Parties to the Nairobi Convention with funding from the Global Environment Facility (GEF) are implementing the Project 'Implementation of the Strategic Action Programme for the protection of the Western Indian Ocean from land-based sources and activities' (WIOSAP).

The Objective of the Project is 'to reduce impacts from land-based sources and activities and sustainably manage critical coastal and marine ecosystems through the implementation of the agreed WIO-SAP priorities with the support of partnerships at national and regional levels'. The WIOSAP Project is partly implementing the WIO-LaB Strategic Action Programme (SAP) for the protection of the WIO Region from land-based sources and activities that was developed as part of the UNEP-GEF WIO-LaB Programme that was implemented in the WIO Region in the period 2004-2010. The WIOSAP Project is thus a response to a request made by the Contracting Parties to the Nairobi Convention and it has availed an opportunity to the governments in the region and their conservation partners to jointly implement strategies of protecting the coastal and marine ecosystems from land-based sources and activities to provide essential goods and services on a sustainable basis.

The Project is being implemented and executed through a 'Partnerships Approach' with the Nairobi Convention Secretariat being the Executing Agency. The participating countries include Comoros, France (La Reunion), Madagascar, Mauritius, Seychelles, Mozambique, Kenya, Tanzania, Somalia and South Africa. France isn't a beneficiary country.

The WIOSAP Project has funded 20 demo projects cutting across the three technical components: **Component A**: Sustainable management of critical habitats; **Component B**: Improved water quality and **Component C**: Sustainable management of river flows. There is also synergy with other projects of the Convention i.e. SAPPHIRE and SIDA Partnership project, where the projects are supporting complementary interventions in country. The WIOSAP project has also supported production of a number of technical guidelines currently being applied in the implementation of project interventions in Mozambique and throughout the region.

Three demo projects have been supported for Mozambique and currently at various stages of implementation:

- 1) Undertake seagrass restoration for Sustainable Shellfish and drafting a management Plan Action guideline for seagrass restoration (Mozambique).
- 2) Mangrove Restoration and Livelihood Support through Community Participation in Limpopo River Estuary, Mozambique
- 3) Environmental Flows for enhanced Biodiversity and Poverty alleviation in the Incomati delta, Mozambique (EFlows-Moz)

2.0 Objective

The objective of the mission is to assess progress made by IPs in the implementation of the 3 demo projects for Mozambique. No site visits have been made to project sites, hence the need for these visits. The Focal Point will facilitate the planning and execution of the different aspects







of the mission from the NIC, courtesy call to the Hon Minister, meeting with MIMAIP and project site visits.

3.0 Shared Learning

The Convention provides a platform for shared learning between and among partners across the region. Implementation of demo provides avails a such a huge opportunity for partners and regional experts implementing similar initiatives to share best practices and lessons learnt. Three regional experts with experience in mangroves (Dr James Kairo from Kenya Marine and Fisheries Research Institute), seagrasses (Dr. Jackline Uku, Kenya Marine and Fisheries Research Institute) and eflows (Prof Japhet Kashaigili, Sokoine University of Agriculture Tanzania) will accompany the Head of the Convention and WIOSAP Project Manager on this mission.

4.0 Expected Outcomes

- 1. Appreciation and confirmation of progress made in the implementation of demo projects supported by the Convention
- Identification of any challenges obtaining and discussions with NIC Chair and IPs on resolution mechanisms
- 3. Understanding on the progress made by Mozambique in her MSP and Blue Economy ambitions and potential synergies with interventions from the Nairobi Convention
- 4. Shared learning between regional experts and IPs
- 5. Capturing relevant information for public stories from the engagements above
